

Information for Applicants

Assessment of Foreign Secondary-School Education (European Baccalaureate) and Secondary-School Education from Germany, Poland, Slovenia or Hungary within the Admission Proceedings to Palacký University Olomouc

➤ Applicants for Bachelor Study Programs and Master Study Programs Not Following a Bachelor Study Program

Within the admission proceedings to Palacký University Olomouc (hereinafter “UP”) for the academic year 2020/2021, UP Faculties will **assess the attainment of the prerequisite of achieving secondary education with a school-leaving exam** in accordance with Section 48 (4) of Act No. 111/1998 Coll. on Higher Education Institutions and on Amendment to Other Acts (the Higher Education Act), hereinafter the Higher Education Act. This prerequisite applies to applicants who have received a foreign secondary education by graduating in a secondary education program from a European school operating in accordance with the Convention defining the Statute of European Schools, or a school where the performance of compulsory school attendance has been approved by the respective Ministry in accordance with the Education Act.

The applicant shall provide documents proving the attainment of the prerequisite of achieving secondary education with a school-leaving exam, an overview of the submitted study applications, and possibly other documents within the term and to the address set by the particular Faculty.

In accordance with Section 48 (4) of the Higher Education Act, UP is authorized to request a **fee for assessment-related tasks** concerning the attainment of the prerequisite for admission to study. More detailed information regarding the payment of this fee is included in a call the applicant receives **in an electronic form via the Online Application Form.**

Important notice:

If **the above-mentioned fee is not paid**, UP will not assess the attainment of the prerequisite of the achieved secondary education with a school-leaving exam, and **will request** submission of a certified copy¹ of a **document demonstrating the general acknowledgement of equality or validity of a foreign certificate of achieved secondary education in the Czech Republic**, acquired in accordance with Act No. 561/2004 Coll. on Pre-School, Primary, Secondary, Tertiary and Other Education (the Education Act), as amended, or in accordance with the preceding legislation.

[Attestation of the attainment of the prerequisite of the achieved secondary education with a school-leaving exam in accordance with Section 48 \(4\) of the Higher Education Act may be done in the following ways:](#)

a) A document proving the applicant has been granted the European baccalaureate

The applicant shall submit:

- A certified copy² of the European Baccalaureate;
- No fee applies – it is an automatically acknowledged document;
- Note: This does not apply in the case of the **International Baccalaureate**, which is considered a document pursuant to Section 48 (4) (d) of the Higher Education Act, and as such is treated in accordance with subparagraph d). For students who have passed the school-leaving exam in Czech language and literature in the common part of the school-leaving examination, if the International Baccalaureate Diploma is an integral part of the certificate of the school-leaving exam, they shall submit a certified copy of the school-leaving examination certificate within the admission proceedings.³

Note: The certificate of the European Baccalaureate is automatically considered a document equal to the Czech school-leaving examination certificate. In order to use it in the Czech Republic, the graduate of a European School does not need any special act to be executed by any administrative authority of the Czech Republic. Education in the higher tier of the secondary level of European Schools (i.e. the 5th-7th year of secondary level of European Schools) is acknowledged in the Czech Republic as education in the education field 79-41-K/410 Gymnázium (see Government Regulation No. 689/2004 Coll. on the System of Education Fields in Primary, Secondary, and Higher Vocational Education, as amended by Government Regulation No. 18/2006 Coll.). b) A document demonstrating the attainment of foreign secondary education that is equal to a document demonstrating the attainment of education issued in the Czech Republic without any further official proceedings in accordance with the Czech Republic's international commitments

The applicant shall submit:

- A certified copy⁴ of a foreign study certificate or a similar document demonstrating foreign secondary education acquired upon graduation in a secondary education program from a foreign secondary school operating in accordance with the legislation of the respective foreign country:

³ School-leaving examination certificate issued by schools that have been granted the approval of the Ministry of Education, Youth and Sports, with a different manner of study completion with a school-leaving exam in the education field 79-41-K/610 Gymnázium – selected subjects in a foreign language (Section 81 (9) of the Education Act for the period from 1 September 2014 to 31 August 2020). IB Diploma is an integral part of the certificate of the school-leaving exam for students who have passed the school-leaving exam in Czech language and literature in the common part of the school-leaving examination. This applies to the following schools: The English College in Prague, Anglické gymnázium, o.p.s., PORG - gymnázium a základní škola, o. p. s., OPEN GATE - gymnázium a ZŠ, s. r. o., 1st International School of Ostrava - mezinárodní gymnázium, s. r. o. Graduates of these secondary schools submit a certified copy of the school-leaving examination certificate within the admission proceedings.

- These are documents demonstrating the achievement of the equivalent to the Czech “maturita” exam in Slovakia, Poland, Hungary and Slovenia:
 - Slovakia - Vysvedčenie o maturitnej skúške (Secondary Grammar School, Conservatory, Secondary Technical School, and Secondary Vocational School)
 - Poland - Swiadectwo Dojrzalosci
 - Hungary - Gimnáziumi Érettségi Bizonyítvány, Szakközépiskolai Érettségi-Képesítő Bizonyítvány, Érettségi Szakiskolai Bizonyítvány
 - Slovenia - Splošna Matura, Poklicna Matura
- No fee applies.

Important information:

- Documents not originally issued in Czech, Slovak or English must be officially translated into either Czech or English.
- Documents must be submitted either in paper form or as PDF files resulting from authorized conversion. Documents in other forms than those mentioned above shall not be accepted.
- Dates and other specific details regarding the submission of documents are set by the Dean.
- Applicants who fail to submit all required documents or their translations, or who fail to submit the documents within the required period, are required by the Dean to remedy the deficiencies or supply the documents.

Other documents

If necessary in the particular case, the applicant is also required to submit the following documents:

- a. The letter of authorization, if a proxy acts on behalf of the applicant in order to demonstrate the attainment of the prerequisite for admission in accordance with Section 48 (4 and 5) of the Higher Education Act.
- b. In case of a name change of the applicant, a certified copy of a document proving this fact (for instance a marriage certificate).
- c. A certified copy of the decision on granting international protection, if the assessment is applied for by a person listed in Section 90 (4) of the Higher Education Act, and if this person intends to use the opportunity to replace some of the documents with an affidavit
